Policy-DRIVEN

Bottom-up needs for scientific support by the Federal Departments

Academic Support

- ⇒ of analytical capacities of federal administrations
- ⇒ for evidence to support decision making



S4Policy Programme Policy-DRIVEN

- Co-financed Maximum budget available via a co-funding scheme
 - Responsible Federal Public Service (FPS) + BELSPO
- Types of research requested
 - Explorative research
 - Create new / advance Research Methodologies
 - Create tools for FPS e.g. data visualisation tool
 - Gathering new data & data analysis
 - Ex-post & Ex-ante policy analysis, policy evaluation
 - Draft (policy, methodological, ...) recommandations

Research Projects

Transdisciplinary (close collab. With FPS)

- Access to data, infrastructure
- Implementation of results
- => Need for frequent interactions

Evaluation & communication results

- Evaluation process by experts
 - Individual -> panel -> final approval by Programme
 Committee
- Informal notification to selected projects
 December 4
- Formal notification to all applicants: communication of selection results mid
 December



Contracts

all information available in "informationfile S4P"

- Co-financed call = at least 2 contracts
 - With BELSPO (Feb 2025)
 - Bilateral with each responsible FPS (Feb 2025 or later)
- Timing sigining contracts with BELSPO
 - 15 Feb 2025 Base Contract
 - 15 Feb 2025 + 3 months time to organise practical arrangements (staff, ...)



UPCOMING DEADLINES

- Eol -> 5 September 2024
 - EOI is compulsory
 - Platform opens on 27 Aug for submission Eol More information will follow
- Full Proposal -> 10 October 2024
 - Use template available online as a guide to prepare submission on platform
 - Timing of project in call is indicative, significant deviation has to be justified in Full Proposal
 - Budget in call is the **maximum** available budget

Digital Transformation

- (3.1) Impact of new technologies on the federal level: threats, opportunities and the
 way forward for implementing the use of AI in the federal administrations (FPS
 BOSA, FPS Social Security, FPS Employment and Federal Audit, budget 855k€).
- (3.2) How to make Artificial Intelligence an asset for the Belgian labour Market?
 (FPS Employment, budget 600k€).

Strategic autonomy and resilience of Belgium

- (4.1) Evaluating R&D support measures and investments in the Belgian Defence technological and industrial base (Ministry of Defence, budget 400k€).
- (4.2) Strategic deployment of the personnel of Defence towards inclusion of different generations, civil personnel and reservist personnel (Ministry of Defence, 800k€).
- (4.3) Strategic autonomy of the Belgian economy scientific support for a better match between economic concepts and data (FPS Economy, budget 150k€).



POLICY DRIVEN call 2024-2025

Inclusion, health and wellbeing

- (5.1) Optimizing ex ante redistribution impact measurements through improved indicators for non-take-up (FPS Social Security and FPP Social Integration, budget 800k€).
- (5.2) Labour market integration of precarious groups: development of an instrument and framework for ex-post evaluation studies, including a case study on people with disabilities (FPS Social Security, budget 900k€).
- (5.3) Innovative and evidence-based strategies to improve the mental wellbeing of independent workers (FPS Social Security, budget 700k€).

Inclusion, health and wellbeing

- (5.4) Implementation of the definition of nanomaterials in (novel) foods by developing and applying optimized electron microscopy-based analysis methods (FPS Health, Environment and Protection of the Food Chain, budget 400k€).
- (5.5) Endocrine disrupting chemicals: Development of new test and chemical risk
 assessment methodologies for thyroid hormone system disruption in humans and the
 environment (FPS Health, Environment and Protection of the Food Chain, budget
 250k€).
- (5.6) History of persecution and social exclusion of people on basis of their sexual
 orientation at different periods in our history (State Secretary for Gender Equality,
 Equal Opportunities and Diversity, attached to the Minister for Mobility and Institute
 for the Equality between men and women, budget 150k€).

Green and societal Transformation

- (6.1) Monitoring Circular Economy in Belgium: methods of data collection, development of Indicators and analyses of circular business (FPS Economy, budget 150k€).
- (6.2) The transition towards climate neutrality in Belgium: how to activate psychosociological levers to foster "sobriety" options? Scoping analysis and sectoral deepdives (FPS Health, Environment and Protection of the Food Chain, budget 600k€).

Green and societal Transformation

- (6.3) Research into the interactions between planetary boundaries and their evolution in preparation for risk analyses for Belgium (FPS Health: Center for Risk Assessment of Climate Change – CeRAC 800k€).
- (6.4) Development and validation of an operational model to assess the dispersion of6sand extraction plumes in the Belgian part of the North Sea (FPS Economy, budget 240k€).
- (6.5) Renewable energy in the transport sector in light of the new EU regulation: potential of Belgium to reach the targets (in 2035) and potential of renewable energy sources within Belgium (FPS Economy, budget 200k€)
